# Constitution and By-Laws

---

## I.—NAME.

The Society shall be known by the name of "The Brant Historical Society."

## I.—OBJECT.

The object of the Society shall be to encourage research into the history of Brant County, to secure an accurate account of its progress and development and to promote a spirit for the preservation of records and memorials of a local and national character.

## III.—MEMBERSHIP.

Any person may become a member by paying in advance an annual fee of fifty cents.

## IV.—OFFICERS.

The officers shall consist of a President, two Vice-Presidents, a Secretary, a Treasurer, a Curator of Museum, one or more Honorary Presidents.

## V.—EXECUTIVE.

The Executive Council shall consist of the President, the two Vice-Presidents, the Secretary and the Treasurer, and all Past Presidents in good standing. Three members shall form a quorum.

## VI.—POWERS OF EXECUTIVE.

The Executive shall have control of all matters connected with the Society, in selecting time and place for holding meetings and the arrangement of programmes and shall certify all accounts for the payment of money and shall appoint two auditors of accounts.

## VII.—AUXILIARY COMMITTEES.

There shall be two committees, one composed of ladies and the other of gentlemen. The duties of these committees shall be to assist the executive council in all matters pertaining to the welfare of the Society. The committees shall each consist of twelve members appointed by the Executive Council, four to form a quorum. Each committee shall have power to appoint a chairman and a secretary. They shall arrange matters submitted to them by the Executive Committee to whom they shall report.

## VIII.—DUTIES OF OFFICERS.

*President*—The President of the Society shall be chairman of all meetings of the Executive Council and of all meetings of the Society and shall be ex-officio member of all committees.

*Vice-Presidents*—The Vice-Presidents in order of seniority shall preside at all meetings at which the President may not be present, or in his temporary absence. Should no President or Vice-President be in attendance at the hour appointed for any meeting, the majority of the members present may choose any person to act as chairman.

*Secretary*—The Secretary shall attend all meetings of the society and of the Executive Council, keep a true and accurate account of the proceedings and record them in a book specially prepared for that purpose, conduct all correspondence of the Society and issue notices of all meetings when directed by the Executive Council.

*Treasurer*—The Treasurer shall receive all moneys and issue receipts for the same, keep an accurate account of the financial standing of the members, pay all accounts authorized by the Executive Council and at the annual meeting of the Society submit an audited statement of the receipts and expenditures for the society year

*Curator*—The Curator shall be the custodian of all documents, records and other property of the Society.

#### IX.—AUDITORS.

Two auditors shall be appointed by the Executive Council, whose duties shall be to examine all accounts of the society and submit a report at the annual meeting.

#### X.—PUBLISHING COMMITTEE.

The President and the Secretary shall be a committee on publishing, printing and advertising.

#### XI.—MEETINGS.

1. Regular meetings of the Society shall be held on the evening of the second Thursday in each month from October to April inclusive.

2. Annual Meeting. The annual meeting shall be held on the thirteenth of March, on which day in 1830, Brantford was laid out by the Crown, unless otherwise appointed by the Executive Council.

3. The anniversary of the Society shall be Brant's Day, November 24th commemorative of Chief Brant's death in 1807.

#### XII.—ELECTIONS.

The officers shall be elected annually at the regular annual meeting of the Society. Should any office become vacant during the year, an election may be held at any regular meeting to fill the vacancy. The voting for officers shall be by ballot.

#### XIII.—DONATIONS.

All contributions of documents and relics of historic value will be thankfully received and officially acknowledged and due credit

given to the donors. Such contributions shall be the property of the Brant Historical Society, unless otherwise stipulated at the time of making the contributions.

XIV.—Copies of all paper read at the meetings of the Society, shall become the property of the Society.

XVI.—ALTERATIONS AND AMENDMENTS.

No change shall be made in the constitution and by-laws unless at least one month's notice in writing shall have been regularly submitted to the Society.

XVI.—ORDER OF BUSINESS.

1.—Reading of minutes of previous meeting, which if approved shall be signed by the presiding officer.

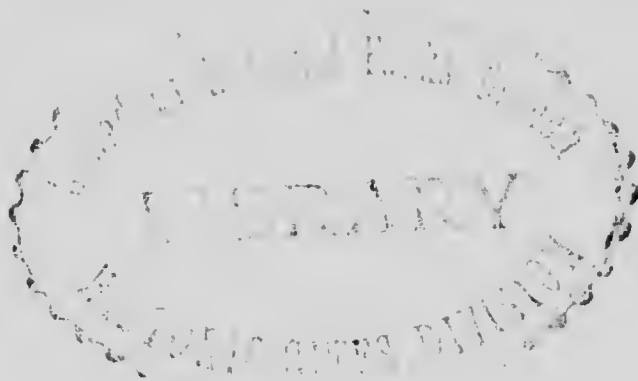

Brant Historical Society endeavors to encourage the collection and preservation of historic records and relics, particularly those of great local value, to arouse interest in history and literature, and to strengthen loyalty and patriotism.

The Society meets at 8 p.m. on the first Friday of each month in the basement of the Public Library Building, George Street, Brantford.

The Annual Meeting of the Society is held on the thirteenth day of March, on which day in 1830, Brantford was laid out by the Crown.

The membership fee is 50 cents. Annual membership certificates may be obtained from the Secretary or through any member of the executive.

## Twelfth Annual Report of Brant Historical Society 1919-1920

---

The past year has been marked throughout the world by unusual unrest associated with the problem of reconstruction consequent upon the termination of the Great War.

In such times concerns of individual interest seem to be supreme to the majority of mankind, while matters of historic interest with no guarantee of immediate material remuneration are left to the few—generally extremely busy men. Consequently the active membership of the Society is not as large as it should be.

The year has been marked by the entry of peace, which did not occasion the enthusiasm produced by the announcement of the Armistice terminating actual conflict, and, in Canada, by the visit of our future sovereign (D.V.) His Royal Highness, Edward, Prince of Wales. The occasion of the prince's visit to Brantford, where he was made a Chief of the Six Nations, October 20, was a gala day for every citizen.

During the year, Mr. F. D. Reville has made excellent progress with his "History of Brantford and Brant County." Brant County stands now in the splendid and enviable position as one of the few counties to have a history published in a single volume.

Much valuable historical work is being continued by the Society which is endeavoring to preserve faithful records of all the various relations of Brant County to the Great War, the records of municipal representatives and the members of parliament. Many valuable historical tasks have been assigned. Rev. Mr. Woodside presented an excellent paper, "The Honorable George Brown, a Brant County Farmer." Mr. Passmore is engaged in similar research work, while his Honor Judge Hardy is preparing a series of papers on "Industrial Leaders of Brantford."

Reference must be made to the historical activities of the Brantford Expositor. Mr. A. T. Whittaker compiled very accurate records of all soldiers enlisting in the city and for several months articles have appeared each week giving a biographical sketch of Brant County natives who have achieved fame in political, commercial, industrial and other phases of intensive human endeavor.

The Society refrained from issuing publications during the war. A manual has been prepared during the present year and papers presented to the Society will be published later.

Important additions have been made to the collections in the museum. Special note is made of the following donations:

Dr. Hutton—propeller of German Aeroplane.

Alex. Monk—Various Indian relics.

Mr. S. F. Passmore, a past president of the Society, contributed the dial and pendulum of the clock first used in Brantford's Municipal Hall, and also a large number of excellently preserved Indian relics and numerous publications of manifest historical value.

During the current year the Society intends to press the campaign to erect a suitable memorial to the late Hon. Arthur Sturgis Hardy and to Messrs. Robert Kennedy Duncan and Norman Duncan.

## Activities of the Society

The Brant Historical Society has endeavored to collect and preserve all records and relics of historical value to the County of Brant and City of Brantford. To accommodate these articles the Public Library Board has graciously given the custody of the museum in the basement of the Public Library to this Society.

At the regular meetings of the Society addresses and papers are delivered dealing with selected phases of subjects of particular interest. These papers are kept on file by the Society and selections made for subsequent publication in the pamphlets issued by the Society.

Through the Historian the Society preserves a faithful chronicle of local events.

The Society endeavors to inaugurate and encourage schemes of particular historic interest. Through the Society a tablet was erected to the memory of the Indian poetess, Pauline Johnson, at entrance of Public Library and the Seal of Brant County was designed and the History of the Bell Memorial was compiled.

At present the Society is endeavoring to collect photographs and biographies of those who gave their lives in the Great War, photographs of places of historic interest, a bibliography of books, papers and manuscripts relative to the History of Brant County.

## The Museum

The Society has already received a large quantity of curios, relics, specimens covering a wide range of scientific interest. These accumulations are being classified and arranged for display in the Museum in basement of the Public Library.

### **The Pauline Johnson Memorial**

On March 7th, 1917, at a public meeting of the Society, the bronze tablet in memory of the late Miss E. Pauline Johnson was unveiled with appropriate ceremony. On that occasion addresses were delivered by His Honour, Judge Hardy, Sir Robert Falconer, Mr. T. W. Standing, Mr. A. W. Burt, Mr. S. F. Passmore and Chief A. G. Smith of the Six Nations Indians.

The beautiful memorial, designed by Mr. Passmore, and handsomely engraved, has now been placed in the entrance hall of the Public Library.

It bears the following inscription:

In Memory of the Canadian Poetess

EMILY PAULINE JOHNSON

(Te-ka-hion-wa-ke)

A Mohawk, born March 10th, 1861, in Brant County, at "Chiefswood,"  
Grand River Reserve of the Six Nations Indians.

Who died March 7th, 1913, at Vancouver, B. C., and after cremation  
was interred in St. Paul's Park.

This Tablet was erected in Brantford, Ontario, by the  
Brant Historical Society, March 7th, 1917.

## Seal of County of Brant



### Description of the Seal

The seal although comprehensive in device has been kept simple in design.

In the shield on a gold background an Indian in full accoutrement stands with pipe of peace in hand, his feet at the water's edge—symbolical of Brant's Ford on the Grand River.

In the vert of the shield is a gold wheel between two golden sheaves of wheat—symbolical of a manufacturing centre in an agricultural community.

The crest is a bear—a totem common to the Six Nations Indians, standing on the oak and pine bound together—emblem of British and Indian unity.

The motto, "Fidelitas et industria"—supplied by Past President, S. F. Passmore, is commemorative of the early Indian loyalty on one hand and indicative of industrial prominence in our own day.

The shield, crest and motto are encircled in a band bearing the inscription, "The Corporation of the County of Brant, Ontario, 1853."
